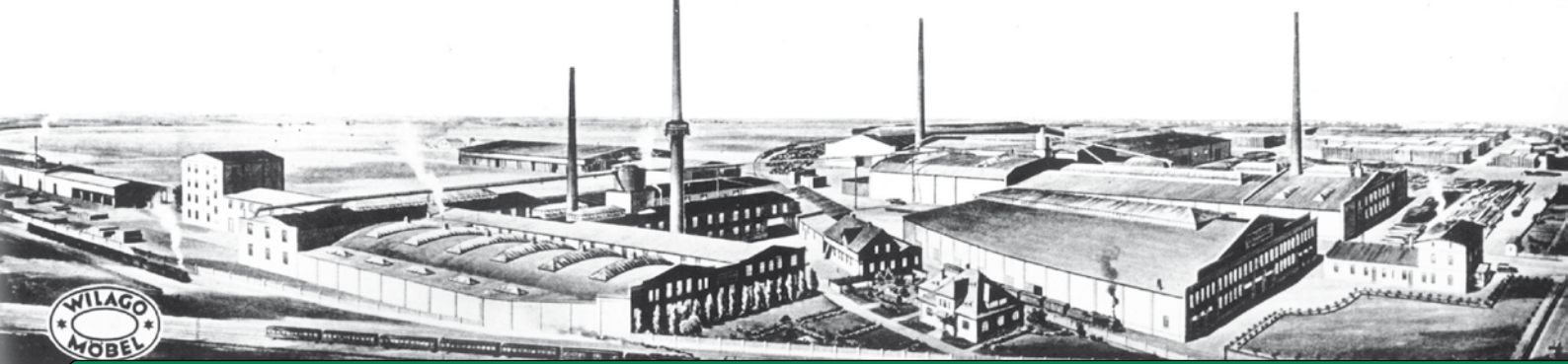

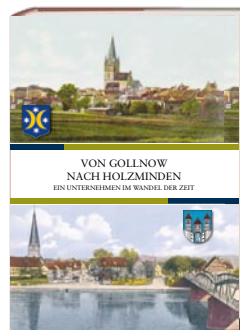


## CORPORATE HISTORY

The Laabs Corporation was founded in Gollnow, Pomerania near the city of Stettin under the name “Wilago” by Willi Laabs (1888 – 1945). “Wilago” produced writing tables as well as office and dining room furniture. Within a period of 25 years, the skilled carpenter managed to establish the company as the third largest line producer of furniture in Germany. “Wilago” had more than 1.000 employees. The end of world war two in 1945 destroyed the lifelong achievement of Willi Laabs who deceased in the summer of 1945.

His wife, Paula Laabs, was displaced from her home together with her seven little children in 1946. After an odyssey they found a new home in Holzminden. The company was reestablished there in 1954 and soon became a sought-after and successful furniture producer. A market downturn within the industry, lead the Laabs GmbH, towards an entirely new business sector. Since 1995 Laabs GmbH is a member of successful companies in the plastic recycling industry.

The family owned company looks back on almost 100 years of living business culture. Success and quality share their roots from the humanity and courage of our founder Willi Laabs. Herbert Laabs and his sons continue that tradition.

## NEW QUALITY PRODUCTS EMERGE

The regrind materials of the Laabs GmbH are reproducible at a standard quality at any time. Modern efficient processing equipment assures highly homogenous granulates. The separation process is done manually to guarantee a pure product. High standards of quality are our trade mark and all products are manufactured under tight recipes. Through grade purification our grinding stock as well as the re-granulate is comparable with the virgin commodity. The new raw material is ready for application making it a true cycle from old to new.

In multiple processes used PVC and production wastes of PVC are processed to become a pure recyclate whereas the Laabs GmbH mainly uses production residue.

/ **Flexible PVC:** We differentiate between 10 different pure flexible PVC types from extrusion, injection molding and compound to the point of blow commodity. These materials are offered as regrind granulate, re-granulate, dryblend, S- and E-PVC as well as a 1 a virgin and b-grade ware.

/ **Rigid PVC:** We differentiate between 25 different pure rigid PVC types from injection molding and blow commodity. These materials are offered as regrind granulate, re-granulate, dryblend, S- and E-PVC as well as a 1 a virgin and b-grade ware.

We naturally carry re-granulate in different colors.

Our wide range of products additionally consists of:

/ **ABS:** Granulate, color extrusion, Type: „DOW MAGNUM 3504“, high impact strength, technical data sheet available. By choice also offered as re-granulate.

/ **Additives, Masterbatche, Liquidcolor:** these high quality materials are solely sold as a virgin product.
